<b>IN-CITY RATES</b>		
SHORT SIDE	\$ 1,000.00	\$ 1,500.00
LONG SIDE	\$ 2,000.00	\$ 2,500.00
<b>OUT-OF-CITY RATES (1.5 x in-city)</b>		
SHORT SIDE	\$ 1,500.00	\$ 2,250.00
LONG SIDE	\$ 3,000.00	\$ 3,750.00

\*FOR ALL WATER METER/TAP SIZES IN EXCESS OF ONE INCH THE CHARGE SHALL BE BASED ON THE ACTUAL COST TO THE CITY OF WHITE OAK AS DETERMINED BY THE PUBLIC WORKS DIRECTOR.

	<b>IN-CITY RATES</b>	<b>OUT-OF-CITY RATES (1.5 x in-city)</b>
SHORT SIDE	\$ 700.00	\$ 1,050.00
LONG SIDE	\$ 1,600.00	\$ 2,400.00

THE ABOVE FEES REPRESENT A NORMAL INSTALLATION FOR MATERIAL AND LABOR UP TO 35 FEET. ANYTHING GREATER THAN 35 FEET MUST BE PERFORMED BY A LICENSED PLUMBER OR PRIVATE CONTRACTOR WITH APPROVAL FROM THE CITY OF WHITE OAK AND AT THE EXPENSE OF THE PROPERTY OWNER.

ALL WATER OR SEWER INSTALLATIONS PERFORMED ON A STATE MAINTAINED ROADWAY (US HIGHWAY 80, STATE HIGHWAY 42, FM 3272, & FM 2275) WILL REQUIRE A PERMIT FROM THE TEXAS DEPARTMENT OF TRANSPORTATION. THE CITY OF WHITE OAK WILL NOT BORE UNDER A STATE MAINTAINED ROADWAY. THE PROPERTY OWNER, AT THEIR EXPENSE, MAY HIRE A LICENSED PLUMBER OR PRIVATE CONTRACTOR TO MAKE THE WATER OR SEWER INSTALLATION UNDER THE SUPERVISION OF THE CITY OF WHITE OAK AND THE TEXAS DEPARTMENT OF TRANSPORTATION.

ROAD BORE APPLICATION FEE (State maintained highways. Fee covers project inspection, plan reviews, & city utility line locates)	\$ 150.00
Application Fee	\$ 25.00
Set meter for abandoned water taps	\$ 25.00
Set meter in subdivision	\$ 25.00
Meter tampering	\$ 225.00

The City is responsible for making taps inside the City except for STATE maintained roadways and inside subdivisions.

The CONTRACTOR is responsible for taps inside the subdivisions and only licensed plumbers will be allowed to make the taps.
