Councilmember Cash moved to approve, seconded by Stephens. Carried 4-0

 - a) Tracie Fears wanted to let the Council know that Jamie Guida is leaving the city for a new job opportunity. He has been with the city for 13 years and will be missed.

4. DISCUSS AND TAKE POSSIBLE ACTION to lower the speed limit on/near Nottingham St, Archer, and Little John.

Jimmy introduced Jennifer Bodovsky to give her presentation to the City Council. She and neighbors would like to see three things done about the traffic in the neighborhood. Speed limit reduction from 30mph to 20mph, No Thru Traffic sign, as well as Children at Play sign. They suggested that the city trim some trees for better visibility.

Mr. Purcell has started looking at what the state requires to change the speed limit. The city can put up the Children at Play sign and the No Thru Trucks now as well as trim trees.

5. DISCUSS AND TAKE POSSIBLE ACTION for the City to be part of the WOISD School Resource Officer Program.

Mr. Gray would like to hire a SRO. The WOISD would pay the salary for the officer, but the city would be the employer. The City of White Oak will supply the police car, maintenance, and fuel. When the officer isn't working for the school district, he/she will also work for the city as an officer.

Councilmember Hood moved to approve, seconded by Cash. Carried 4-0

6. CONSIDER AND/OR APPROVE for Terry Roach and Jimmy Purcell's vehicles to be used as emergency vehicles with equipment for the city.

Councilmember Stephens moved to approve, seconded by Hood. Carried 4-0
